# Item No:31.03 Relaxation in fee to be charged from SC/ST students admitted under PMSS Scheme w.e.f. academic session 2018-19.

It is informed that total SC/ST seats in the Engineering Wing of the institute in the session 2017-18 were 166. The total numbers of seats filled in the SC/ST category and availing PMSS benefit in the last three years were as follows:

Sr. No.	Academic Year	No. of SC/ST students availing PMSS
1.	2017-18	44
2.	2016-17	36
3.	2015-16	46

From the above said data. it is apparent that about 76% seats of SC/ST remains vacant. Further, it is reported that total fee charged from SC/ST students admitted under PMSS is approximately Rs. 4408/ per semester. On the other hand, the total fees charged from the general category candidates is Rs.51788/- per semester.

In case of SC/ST students, Rs 40,075/- (apprx.) per semester per student is reimbursed by the Government of Punjab. Above said data for the year 2017-18 reveals that if all the seats would have been filled then institute will get Rs.5,32,19,600/-(166 x 40075x8) approximately as the fees reimbursed from Government of Punjab during the entire degree course. Whereas actual reimbursement will be Rs 1,41,06,400/-(44X40075 x 8) approximately for the whole degree course of

students admitted in the year 2017-18 in the Engineering Wing of the Institute. Similar situation is existing in Polytechnic Wing of the Institute.

Further, as per Punjab Govt, notification No. 3/94/2016-SAI/1493 dated Chandigarh 22 July 2016, it was directed not to collect any fee from SC/St Students except caution money/security deposit, which are refundable in nature (Annexure-XVII, Page No.55-58).

A meeting of HODs and Dean Academic was held on 21.03.2018 at 11.00 AM regarding fee to be charged from SC/ST students admitted under PMSS scheme. In this meeting, it was unanimously decided that no fee should be charged from the SC/ST students who are admitted under PMSS from the academic session 2018-19 onwards (Annexure-XVIII, Page No.59).

Therefore, keeping in view the larger interest of SC/ST community, it is proposed that no fee should be charged from the SC/ST students of Engg. Wing, Poly Wing, B.Arch., MCA and non-AICTE courses to be admitted under PMSS scheme from Academic Session 2018-19.

The matter is put up before BOG for consideration and approval please.

#### Item No:31.04 Fee relaxation to students admitted under CMSS Scheme

The Punjab Govt. had implemented Chief Minister Scholarship Scheme (CMSS) in Govt Engg. Colleges and Polytechnic Colleges in the year 2017-18 as per detail below:

Sr No	Marks in 10+2/ (Eligible qualification)	%age of Tuition fee Waived
1	90 % and above	100%
2	80% and above but less than 90%	90%
3	70% and above but less than 80%	80%
4	60% and above but less than 70%	70%

The BOG of the institute in its 28<sup>th</sup> meeting held on 18.07.2017 vide agenda item no. 28.3 had decided that CMSS shall be applicable in the institute, as per the Govt Policy on all the students of Diploma, B.Tech, B.Arch, BCA students to be admitted in the First Year of the Session 2017-18. To avail the benefits of CMSS continuously in the subsequent semesters, the student must have to clear all subjects of the previous semesters; otherwise, the benefits of the CMSS shall not be given to him / her.

The total students admitted under CMSS scheme in Engineering Wing and Diploma Wing courses were 203 & 85 and the benefit given to them was Rs 44.5 Lacs and Rs. 7.5 Lacs, respectively, for first semester. This amounts to Rs 2.5 Crore for the whole course.

In the last financial year 2017-18, institute had used Rs. 9.00 Crore (approx) from the internal savings of previous years to pay salary to the staff. If CMSS scheme is adopted for the academic year 2018-19 also, then institute will have to use Rs. 11.00 Crore Crore from internal savings. Presently institute has Rs. 13.00 Crore as savings from tuition fee account as on 31.03.2018.

A meeting of HODs and Dean Academic was held on 21.03.2018 at 11.00 AM regarding implementation of CMSS scheme on 2018-19 Batch. In this meeting, it was decided that the CMSS Scheme should be implemented in the institute for the academic year 2018-19 with some modification as per details below (Annexure-XVIII, Page No.59):

### Item No:31.06 Review of continuation of School wing (10+1 & 10+2 classes) in the college campus.

A meeting of Head of Departments & Dean Academics was held on dated 21-03-2018 to review the progress of School Wing (Annexure- XXIII, Page No.64). It was discussed in the meeting that School wing (10+1& 10+2 Non-medical classes) was opened in the campus with aim of providing facility to poor & meritorious students of this area by keeping fee at par with Govt. schools. At that time, it was thought that these students will join degree/diploma courses of this campus, but the trend shows that these students didn't take admission in Engineering/ Diploma courses. Further, over the years, the admission in the school has been decreased and found to be even less than 50%.

Therefore, it was decided in the HODs meeting that it is not financially viable to continue 10+1 & 10+2 classes in the campus & hence admission in the school wing be discontinued from the session 2018 onwards.

The matter is placed before the BOG for taking appropriate decision.

Mrs. Renu Rani w/o Late Sh. Raj Kumar, Peon has requested vide letter dated 15.03.2018 for regularization of her services (Annexure-LI, Page No.144)

It is informed that as per the approval of Hon'ble Chairman BOG vide file No. 248 dated 12.03.2015 (Annexure-LII, Page No. 145-148), a post of Peon-SC on 03 years contract basis was offered to Mrs. Renu Rani vide appointment letter no. 8300-04 dated 18.03.2015 (Annexure-LIII, Page No.149-150) on compassionate Ground in the Engg Wing of the Institute due to death of her husband Mr. Raj Kumar, who was working as Assistant Professor in the Institute.

Mrs. Renu Rani had joined as Peon in the Institute on 20.03.2015 (FN) and her contract period has been completed on 19.03.2018.

It is also mentioned here that the Mr. Harsh Manni S/o Late Sh. Suman Kumar was appointed as Junior Technician by the BOG vide agenda item No. 28.04 on compassionate grounds due to death of his Father Mr. Suman Kumar, who was working in the institute as Junior Assistant. He was appointed on contract basis for a period of 02 years on regular pay scale and other admissible allowances. Further, it was decided that his services will be regularized based on his performance and requirement of the institute after completion of 02 years.". Accordingly, Mr. Harsh Manni was offered an appointment to the post of Junior Technician on compassionate ground vide this office letter no. 1736 dated 24.07.2017 (Annexure-LIV, Page No.151-152).

It is mentioned that as per memo no. 85-88/S-4/ECC/2018 dated 19.01.2018 received from the office of the DTE/IT stating that the cases related to extension of contractual Services be put up in the BOG of the institute (Annexure-LV, Page No.153).

It is also mentioned that in the 30<sup>th</sup> meeting of BOG vide agenda item no. 30.2, while discussing the action taken report, it was decided to refer back the case of regularization of services of Mrs. Savita Sharma as a peon (Compensation ground) to the office of DTE/IT, Punjab, stating that she was eligible for appointing as a peon on regular basis on compensatory ground. However, she was appointed on contract basis at that time to check her performance. As her performance is found be satisfactory, therefore her services should be regularized. Accordingly her case was sent to the office of DTE/IT vide letter No.6637 dated 28-03-2018 (Annexure-III, Page No.40)

As per the report dated 27-03-2018 submitted by Head of Department of Management Wing, work and conduct Mrs. Renu Rani, Peon is very good & her services in the department are required. He has recommended for regularization of her services in the institute (Annexure-LVI, Page No.154). There are 21 posts of peon in the institute out of which 16 post are filled

#### Item No.31.10 Participation in the different Education fairs for admission and to hire different consultants- regarding

The Institute has constituted the Admission Committee headed by Dr.Lalit Sharma, Associate Director and Dr.Sangeeta Sharma, Associate Professor. The Admission Committee has received one proposal regarding Education Fair being organized at Patna, Bihar. In this Education Fair, they have demanded Rs.1.00 Lakh to become main sponsorer or Rs.40,000/- for Co-sponsorer (Annexure– LVIII, Page no.156-159). Further, as per telephonically talk by Dr.Sangeeta Sharma, they agreed to reduce the rate, being Government College.

The Institute often receives such kind of proposals from different organizations for the Educational Fairs being held at J&K, Nepal, Bhutan and many other places in India. Since the admission in the last year was less than 50%, it will be in the interest of institute to use such platform for admissions. Further, Institute often receives the proposal from the consultant and they are also demanding consultancy charges for the admission.

Similar practice is being followed by other private engineering colleges.

The above said proposal is put forward to the BOG for taking appropriate decision.

#### Item No.31.11 Implementation of ERP solution in the Campus-regarding

In the 11th meeting of BoG vide agenda item 11.2, the Board had approved to purchase ERP Solution from TCSion for providing ERP services in the institute. Accordingly it was setup in the campus but services provided by TCS was not upto the mark. Moreover TCS ion had increased the prices to many fold. At the final meeting held in the office of DTE/IT Punjab, Chandigarh under the Chairmanship of Sh Mohanbir Singh Additional Director TCS was asked to provide the solution at maximum of Rs 50/-per user per month to which the company officials did not agree and contract got terminated.

In the meantime one of the faculty member Dr Satvir Singh developed limited software for conducting the exams in the institute as per the UGC regulations for autonomous institute. An honorarium of Rs 6000 per month was paid to him against this service. Dr Satvir Singh has left the institute as he had been offered the job at IKGPTU. He agreed to continue the services free of Cost till we get an alternative arrangement.

Institute is of the opinion that this software development and data management be out ourced to some professional company so that institute can get the services without depending upon the employees. Accordingly the request for Proposal (RFP) were floated in the Newspaper for demonstration of various companies and our requirement of different departments were finalized and two bid tender was floated in the month of

Dec 2017. Three experienced companies has offered their bids as under (Annexure-LIX, Page No. 160).

In addition to above participants, Purchase Committee has come across one more ERP Solution which is available on GeM Portal at the cost of Rs 274.5/user/annum (Rs 22.8 per user/month) +GST promoted by a company iweb Technology Solutions Pvt Ltd. which can also serve the purpose of the institute with little customization. Committee has also seen its demonstration and seen its trial version. Complete proposal of I web is placed at Annexure –LX, Page No161-177.

Considering the above facts and figures Institute has following options to Choose :

#### **Option 1 (a):**

To procure the service from the vendors M/S Solitaire InfosysPvt Ltd, Mohali, who has quoted the lowest lumpsum price of Rs. 2500000.00+GST in the tender, However extension for the validity of prices needs to be taken from the vendor.

#### **Option 1(b) :**

To procure the service on cloud from the vendors M/S Solitaire InfosysPvt Ltd, Mohali, who has quoted the lowest rates price of Rs. 45.00 per user per month + Taxes (Min 2000 user) in the tender, However extension for the validity of prices needs to be taken from the vendor.

#### **Option 2 (a)**

To procure the ERP solution form M/s iweb Technology Solutions Pvt Ltd through GeM @ Rs. 274.50 per user per annum (approx. Rs 22.87 per user per month). Min payment of Rs. Rs5.49 Lacs per annum for 2000 users needs to be paid. Company has also asked for an advance of Rs. 82350.00 i.e 15 % of the annual payment.

#### Option 2 (b)

M/s Iweb Technology Solutions Pvt Ltd has an MoU with Kotak Mahindra Bank under which they are ready to provide the same solution as specified at option 2 (a) at FreeNomics model under which Institution will not pay any amount to any company. However, fee collection of the students shall have to be through Kotak Mahindra Bank. In return Kotak Mahindra Bank shall charge Rs 50.00 per student per semester directly from the student along with fee collection.

In case any option among Option 2 (a) or Option 2 (b) is chosen, company Iweb Technology Solutions Pvt Ltd has demanded Rs 1.5 lacs additionally as one time fee for Data Migration from existing system to the new system.

The complete case is put up before BOG for consideration and appropriate decision.

#### Item No.31.12 Continuation of services of Guest Faculty who were appointed in the academic year 2017-18 on consolidated salary of Rs. 15000/- per month on 11 month basis/lecturer basis

In every year, Institute issues an advertisement for appointment of guest faculty on a consolidated salary of Rs. 15000/- per month basis for a period of one academic year.

Accordingly, in the year 2017-18 an advertisement was published for appointing guest faculty on consolidated salary/lecture basis and earlier faculty members appointed as Guest Faculty on consolidated/lecture basis in the year 2016-17 were relieved.

However, some faculty members had filed CWP No. 13610 of 2017 in the Hon'ble Punjab and Haryana High Court with the pray to quash the action of respondents to relieve the petitioners before summer/winter vacations every year and further to allow them to continue till regular appointments are made. Further, they had filed CM No. 10058 of 2017 in the CWP No. 13610 of 2017. The Hon'ble Punjab and Haryana High Court had given the following directions to the Institute on 28.07.2017 (Annxure-LXI, Page No.178):

"Notice in the application to the counsel opposite, returnable for 4.8.2017

In the meanwhile, it is directed that the respondent institute shall not issue appointment letters for the post of Assistant Professors in the stream of Computer Science and Engineering in pursuance to the Interview that has been held in pursuance to the Advertisement No. Estt/1/2017 (Annexure P-2)."

Accordingly, in compliances of the above said orders, all the petitioners who were relieved after the completion of an academic year 2016-17 were asked to join back in the institute. Subsequently, the Hon'ble Punjab and Haryana High Court had disposed of the CWP No. 13610 of 2017 stating that the principal prayer for not replacing the petitioners by another set of employees has been conceded to and appointment letters have been offered to all petitioners and four of them have joined their duties. As the main relief has been granted, the state shall examine the matter with regard to remaining prayers made in the present petition CWP 13610 of 2017 as per law within a period of three months from the date of receipt of certified copy of this order (Annexure-LXII, Page No.179-180).

It is informed that in the year 2017-18, many other faculty members were also appointed as guest faculty on consolidated salary/lecture basis and as par past practice they are required to be relieved after the completion of current academic year. As per the past practice, institute has to publish an advertisement for recruitment of Guest Faculty for the academic session 2018-19. They have given the representation for similar relief (Annexure-LXIII, Page No.181-191).

However, keeping in view the orders of Hon'ble Punjab and Haryana High Court in CWP 13610 of 2017 that not replacing the one set of employees by another set of similar situated employees, fresh advertisement should not be published and the existing Guest Faculty should again be appointed for the academic year 2018-19 also.

Therefore, it is proposed that existing Guest Faculty appointed on consolidated salary of Rs. 15000/- per month basis/lecture basis in the year 2017-18 should be allowed to perform their duties for the academic year 2018-19 and onwards till the appointment of faculty is made on regular basis/Contract basis on regular pay scale.
