To consider representation of some of the employees from Non teaching/technical Staff regarding allotment of houses to Lecturers appointed on contract basis, as per directions of the Hon'ble Punjab and Haryana High Court.

The Bye Laws contain the House Allotment Rules according to which the employees of the College are allotted the houses on the college campus. Criteria for allotment is the basic pay that the employee is drawing and the post that he is holding. According to the Project report of the College 75% of the faculty and officers are to be provided accommodation in the College Campus whereas 50% of the other staff is to be provided accommodation in the College Campus. The Bye Laws are applicable to the all employees as per rule 1.3 of the Bye Laws which is reproduced as under:

"Except as otherwise expressly provided for, these bye laws shall apply to every person in the whole time employment of the Shaheed Bhagat Singh College of Engineering and Technology Ferozepur Society (Regd) other than a person employed under the contingent establishment."

- 2. That the rule 1.1(m) gives the definition of the employee as under:
  - "Employee" means any person employed or appointed to any service, office, or post in connection with the affairs of the Society but excluding any work charged person working on part time and work charged basis."
- 3. That rule 12.27 of the College Bye Laws provides as under: "On any question of interpretation of these Rules the Principal decision shall be final. However, the employee may appeal to the Board whose decision shall be final in the matter."
- 4. That the Government of Punjab vide its letter No. 1515 dated 28.4.2003 issued a policy for recruitment of teaching faculty in the State managed Engineering Colleges. According to this policy all the posts of teaching faculty in

the Engineering college, were to be filled up by recruiting faculty on contract basis for a period of three year which contract could be extended for a further period of two years copy placed at Annex.-III on pp 44-45.

5. That there is a provision in Rule no.3.11 of the College Bye Laws for recruitment of the employees on Contract basis which reads as under:

"Subject to the provisions contained in these rules the Board may appoint any person on contract basis in the prescribed scale of pay and on the same terms and conditions applicable to the relevant post for a period not exceeding three years with a provision of renewal for further periods. For making such appointments, the Chairman may, at his discretion, constitute such ad hoc Selection Committee as the circumstances of each case may require."

6. That according to the above policy of the State Government the posts of teaching faculty were filled up by appointing the faculty on contract basis for a period of three year as recommended by the Govt. after following proper procedure. Since all faculty members were in whole time employment of the College and their salaries are not under the contingent establishment, & they fall in the definition of the employees the Principal who is competent authority allotted houses to some of the contract faculty members as per their seniority and entitlement vide order No. SBSCET/FZR/PO/9106-16 dated 4.3.2005. (placed at Annex.-IV page no.46)

7. Some non teaching employees raised an issue that the employees who are on contract basis are not entitled for accommodation at the campus and only regular employees are entitled. Their representations were replied quoting from the Bye Laws that the employees on contract basis also fall in the definition of employee as per definition of employee given in

the Rules and they are entitled to be kept in the seniority list for allotment of accommodation. Representations and the reply in an annotated form are reproduced below for perusal of the Board:

III A house D-I/IV having market rent of Rs.2250/- P.M. has been allotted to contract employee on rental basis @Rs600/- per month. How it can be justified?

Regarding para No.(III) of your letters, it is to bring to your to your notice that houses on the campus are allotted based on market rent of the magnitude of rent to be collected from allottee. The houses on campus are allotted to the employees of the College based on eligibility and Station Seniority as per College ` Bye-Laws. Further market rent is charged from those who continue occupying houses in unauthorized way against the rules. It is worth mentioning that in the past the College has been allotting houses on campus to adhoc employees and part time teachers engaged on hourly basis.

It is further added that the house allotment has been done strictly in accordance with the College Bye-Laws. The same has been explained to the members

of D-type houses and allotment of D-I/IV to B.O.G. for final decision on this matter

of your association who came to see the undersigned personally to discuss this issue. A written reply has also been given to you vide letter No.1931 dt.09.05.05 quoting all relevant rules. (Annex.-V pp.49-50)

In my opinion, the case is not fit to be referred to the higher authorities for its consideration as no infringement of rules has taken place while allotting house No.D-I/IV to Mr.Dharam Pal

8. That under the Bye Laws the power of interpretation of Bye laws vests with the Principal and a provisions is made under rule 12.27 for making an appeal from the decision of the Principal to the Board. Rule 12.27 is reproduced below:

"On any question of interpretation of these Rules the Principal's decision shall be final. However, the employee may appeal to the Board whose decision shall be final in the matter."

9 Some of the employees filed Civil Writ Petition in the Hon'ble Punjab and Haryana High Court bearing No. 19175 of 2005 titled as Naresh Kumar and others vs. State of Punjab and others which was disposed of by the Hon'ble Court on 21.9.2005 by passing the following order:

"The instant petition filed under Article 226 prays for quashing order dated 9.5.2005(P.5\*) and order dated 3.8.2005(P.8\*) whereby the allotment of houses has been made to the contract employees and claim has been made that the allotment of the houses should be made to the regular employees. In that regard, the petitioner has filed representation P.6 and P.7 on 25.5.2005 and 29.7.2005 (please refer pp 47-48) respectively. However the Principal respondent No. 2 on 29.7.2005 had already taken a view by observing that he did not find any merit in the case to refer the same to the Board of Governors as according to Bye law 12.27 only Board of Governors is competent to decide the afore- mentioned issue.

At the outset, we put it to Shri J.S.Ahluwalia learned counsel for the respondent No.2 Shaheed Bhagat Singh College of Engineering and Technology, GT Road, Ferozepur whether the College is prepared to consider the representative of the petitioners Annexures P.6 and P.7 (Please refer to page no.47-48) by referring it to the Board of Governors, Learned counsel has readily agreed for making a reference to the Board of Governors. Accordingly, we dispose of the writ petition by directing respondent No.2 to refer the matter to the Board of Governors without any further delay and preferably with in a period of one week from today. If the reference in accordance with the above directions is made then the Board of Governors shall decide the same within a period of two months thereafter. Till then the stay order passed by this Court on 9.12.2005 shall continue to operate" (A copy of the order of the Hon'ble Punjab and Haryana High Court dated 21.9.2005 (copy placed at annexure-VI on page no.52-57)

- 10. The representation made by the employees refereed to in the orders of the Hon'ble Punjab and Haryana High court as P.6 and P.7 are annexed as Annexure-V on page no.47-48.
- 11. These representations stand replied by the Principal of the College and the point raised and reply of the Principal has been given above in paragraph 6 in annotated form is annexed-V on page no.49-51.
- 12. The employees made a representation dated 3.5.2005 enclosed with the CWP as P.4 (please refer to pp 96-100) stating that employee on contract basis who is not entitled for rent free accommodation is not eligible for allotment of houses and that Mr. Dharam Pal (Lect. On contract basis ) was not eligible for allotment of house vide office order No.9106-16 dated 4.3.2005, (Please refer Annex-IV to page no.46 ) as his name was not appearing in the Station Seniority list prepared by Estate Office. This letter was replied by the Principal vide his letter No. 1931 dated 9.5.2005 (please refer Annex.-V page no.49-50 ) stating that college Bye Laws and house allotment rules are applicable to all employees of the college and definition of Employee in the College Bye Laws also covers whole time employees on contract basis. Regarding the issue raised by them that

Mr. Dharam Pal is not eligible for house allotment as his name was not appearing in the station seniority list prepared by the Estate Office. It was made clear to them that Mr. Dharam Pal joined the College in Aug. 2004 whereas the list was prepared in July,2004 therefore it was not possible to include his name in the list. However the allotment of house to Mr. Dharam Pal is justified as per rule 12.4 of the College Bye Laws that read as under:

- ".... for the purpose of allotment of a house in category Seniority of an eligible employee shall be reckoned from the date when he becomes eligible for that category of house...".
- 13. Therefore Mr. Dharam Pal (Lect on contract basis) becomes eligible for allotment of C-type of house w.e.f. date of his joining the College. As a C-type house was not available therefore Mr Dharam Pal was considered eligible for allotment of D-type of house on his request as per rule 12.4.(ii) of the College Bye Laws. That reads as under:

"A Staff member on his request may be considered eligible for allotment of house of lower category if house in that category of his entitlement is not available. For such allotment, a staff member holding higher post shall be considered senior to all other employees who are otherwise eligible for that category of houses"

14. The Civil Writ Petition and the reply filed by the College are placed at Annex.-VII on pp 58-132 and Annex.-VIII pp 133-148 for ready reference.

In view of the directions given by the Hon'ble Punjab and Haryana High Court P.6 and P.7 (please refer to page no. 47-48 as annexed with the Civil Writ Petition No. 19127/05 submitted by the petitioners are placed before the Hon'ble Members of B.O.G. along with other papers of the case for its consideration under Rule 12.27 of the College Bye Laws to take a final decision on the representations of the petitioner in the Civil Writ Petition.
