Item No. Re-appropriation and ratification of the expenditures

5.04

Following items & expenditures had been made in anticipation to the budget approval for the year 2023-24, with the approval of Hon'ble Vice Chancellor put up for ratification:

• Water and Electricity Charges

An amount of Rs 100.00 Lacs was kept in the Budget 2022-23 for Water & Electricity Charges related activities. However, an extra expenditure of (Rs. 7.12 Lacs) has been done in excess of the approved budget amounting to a total of Rs107.12 Lacs. Expenditure has increased as all the classes are held offline which were held online in the previous two years due to Covid-19 situation. Re-appropriation of funds has been done and the extra amount has been paid to the Electricity Board. (Annexure **E, page no.34-35**)

• Advance for the maintenance of Power House

An urgent requirement for power house was submitted by OIEM of the University regarding repair of power house (**Annexure F, Page no. 36**). An advance of Rs. 10,000/- was sanctioned with the approval of Registrar of the University for the purpose of power house of University in anticipation to the budget approval financial year 2023-24.

• Continuation fee for 2021 batch and onwards.

Further, a continuation fee/Re-admission fee has to be charged from the students of the university if they rejoin the course after a gap of one or more years. In this regard an approval has been taken from the chairman finance committee to charge a continuation fee of Rs. 5000/- (Five thousand) which is equivalent to as charged by IKGPTU and MRSPTU. The copy is placed as (**Annexure-G, page no 37**) The same has already been approved in the 2nd meeting of the academic council vide agenda Item No. 2.12.

• Payment of pending 30% salary of teaching staff.

30% pending salary for the months of April 2021 to September 2022, of three Professors namely, Dr. Tejeet Singh (ME), Dr. Rajeev Garg (CHE) and Dr. Raminder Pal Singh (DASH) has been paid after vetting of their service book by the DTE/IT, Pb Chandigarh worth Rs 30.51 Lacs. (Annexure H, Page No. 38-41) anticipation of budget approval of 2023-24

• Wages of outsources staff (Housekeeping, horticulture, office-and security staff, electrical-and maintenance staff)

Rs 11.00 Lacs had been paid for the wages to outsource staff for the month of March 2023 in anticipation of budget approval of 2023-24 (Annexure-I, Page No. 42-43).

The above said expenditures are placed before the members for ratification, please.

Item No.To approve the rate of Interest on CPF/GPF contribution during5.052021-22 as per Government approved rates.

As per college bye-laws, the rate of interest paid on CPF/GPF contribution was the same as being paid to the Punjab Govt. employees.

Further, it is brought to the kind notice of Finance committee that as per the University/college Byelaws, chapter VII & VIII, Provident fund rules and General Provident fund cum pension cum gratuity rules, the Accounts of CPF and GPF of employees are to be maintained at college level. These funds are kept in scheduled nationalized banks with a rating of AAA or above as per college Bye-Law rules chapter VII & VIII. The rate of interest paid on CPF/GPF stands automatically revised whenever Punjab Govt. revises rate of interest payable on CPF/GPF to their employees. The College Bye-Law rules no. 7.11(a) and 8.10.5 are reproduced as under: -

Rule no. 7.11 (a) Regarding Contributory Govt. Funds

"The rate of interest to be allowed on all sums deposited to the Fund shall be such as may be determined from time to time by the Board."

Rule no. 7.16 (e) regarding Gratuity:

"The above rules will stand automatically revised as and when the corresponding rules of Punjab Govt. are revised."

Rule no. 8.10.5 regarding General Provident Fund and Pension fund:

"The rules relating to General Provident Fund shall be the same as applicable to Punjab Govt. employees from time to time in respect to employees of the college who opt for pension."

In the 4th meeting of Finance Committee of the University, it was decided to write the letter to the Finance Department and DTE/IT Chandigarh for the clarification regarding interest to be paid on CPF/GPF. Letter vide reference no. SBSSU/FZR/2353 (Annexure J, Page No.44) dated 18/08/22 was sent but reply is still awaited.

Keeping in view of the college bye-laws as mentioned above, the matter is placed before the Finance committee for approval of rate of interest payable to staff on CPF/GPF account for the year 2021-22 onwards as being paid to Punjab Govt. Employees.

The matter is placed before the Finance Committee for approval please.

Item No. Recovery of excess security money refunded to students by Mr. 5.06 Pardeep Kumar (Sr. Asstt.).

In the 29th & 30th Finance committee meeting vide Agenda item number 29.14 & 30.05, it was decided that efforts should be made to recover the amount from remaining 26 students. After that, Mr. Pardeep Kumar, Sr. Asstt (under suspension) was instructed to recover the excess amount of security from the students.

Since then, no student has deposited excess security amount refunded to them in the Accounts section. So, the said amount worth Rs. 52000 could not be recovered and hence it was decided to recover the remaining amount of excess security money from the salary of Mr. Pardeep Kumar (Sr. Asstt.), under suspension, after taking approval from the competent authority (Annexure-K Page No.45-56). Accordingly, the remaining amount of Rs. 52000/- had been recovered in 04 installments (13000/- per month) from the salary of Mr. Pardeep Kumar, Sr. Asstt. (Under suspension) during the months of April-2022, June-2022, August-2022 & Sept.2022.

A committee was constituted by Chairman of Finance committee to formulate the fee structure for session 2023-24 vide office order no. SBSSU/FZR/5484 dated 1.2.2023. In the fee structure of PhD Program of session 2022-23 and onwards, the clarification regarding inclusion of semester fee of 1st semester in Pre-Registration Fee (Rs 25000/-) was required as this was not mentioned in the approved fee structure. In this regard, an email was sent to earlier Dean R & D for clarification of the same. The comments of earlier Dean R & D are mentioned below,

"With reference to your email regarding 1st semester fee of Ph.D. students of session 2022-23, it is to clarify that pre- registration fee i.e. Rs.25000/- submitted in 1st semester also includes first semester fee. This is for your kind information."

Further, the fee for extension for submission of the thesis for 7th year (15000/-) was also added in the revised fee structure as this was not mentioned earlier. All the necessary documents are placed as **Annexure N** (**Page No 106-111**).
